PUBLIC CONTRACTS REVIEW BOARD

Case 1429 – CT 3029/2019 – Tender for Restoration and Structural Works at the Malta Maritime Museum, Birgu using Environmentally Friendly Materials

The tender was published on the 21st June 2019 and the closing date of the call for tenders was the 29th August 2019. The estimated value of the tender (exclusive of VAT) was € 872,416.

On the 31st January 2020 Vaults Ltd filed an appeal against Heritage Malta as the Contracting Authority objecting to their disqualification on the grounds of their bid being deemed to be administratively non-compliant. A deposit of € 4,362 was paid.

There were three (3) bidders.

On 25th February 2020 the Public Contracts Review Board composed of Dr Anthony Cassar as Chairman, Dr Charles Cassar and Mr Lawrence Ancilleri as members convened a public hearing to discuss the objections.
