Tender for the Supply and Installation of Kitchen Equipment.

The Tender was published on the 30^{th} August 2015. The closing date was on the 14^{th} September 2015. The estimated value of the Tender is €60,092.37 (Exclusive of Vat).

Three (3) bidders had submitted offers for this Tender.

On the 2nd December 2015 The Catering Centre Limited filed an objection against the decision of the Contracting Authority to find their bid non compliant.

The Public Contracts Review Board composed of Dr Anthony Cassar (Chairman), Dr Charles Cassar and Mr Lawrence Ancilleri as members convened a hearing on Tuesday the 19th January 2016 to discuss the objection.

Dr Paul Borg on behalf of the Contracting Authority explained that the Tender was being funded with European Union Funds but since the validity period had lapsed, there were no longer any funds available. The Tender had to be cancelled.

Dr Franco Vassallo on behalf of the Appellant said that he was very sad to learn of the loss of such funds but admitted that at this point the Tender could only be cancelled. The responsible authority should ensure that there should be no similar occurrences.

This Board,

Having noted the Appellant's Objection in terms of the "Reasoned Letter of Objection" dated 2 December 2015 and also the Contracting Authority's opening submission during the Public Hearing held on 19 January 2016, in that:

a) The Appellant was concerned that he was being informed, during this Hearing, that this Tender would be cancelled.

Having considered the Contracting Authority's submission during the Public Hearing held on 19 January 2016, in that:

a) The Contracting Authority informed this Board, during the Public Hearing, that since this Tender was to be financed through EU Funds

and the latter were no longer available; this Tender is to be cancelled.

Reached the following conclusion:

1. This Board opines that since the EU Funds to cater for this particular

Tender are no longer available, the merit of this objection does not

need to be treated. However, this Board would advise that the

Contracting Authority should investigate why such EU Funds were

no longer available.

In view of the above, this Board recommends that the Tender is to be

cancelled and that the deposit paid by the Appellant is to be fully

reimbursed.
