### **Ittra ta' Oggezzjoni ta' Vaults Co. Ltd: CFT: Quotation for the Supply of Pre-mixed mortar to be used for Plastic Repair**

Bil-prezenti, Vaults Co. Ltd qed tilmenta ai termini tal-ligi mid-decizjoni tal-Awtorita' Kontraenti li biha giet skwalifikata u li l-kuntratt pubbliku hawn fuq imsemmi gie kaċcellat.

L-Awtorita' Kontraenti, fl-ittra taghha tal-11 ta' April 2024, iddecidiet illi l-esponenti gie skwalifikata minhabba li *“During sample testing, as part of the evaluation of the Technical Offer, the Evaluation Committee noted that the submitted offer is a bit on the yellow side when it comes to colour and it is very hard to finish due to large grains. This renders the proposed product as technically non-compliant”* u sussegwentement ghazlet li ma tirrakkomandax is-sejha lil xi operatur ekonomiku ai termini tal-artikolu 18.3(a) tal-General Rules Governing Tenders.

### **Dwar ir-Raguni ghall-Iskwalifika**

Fl-ewwel lok, l-Awtorita' Kontraenti tghid li l-offerta tal-esponenti kienet teknikament mhux konformi minhabba zewg ragunijiet. L-esponenti ser tezaminahom wahda wahda:

- (i) *“[T]he submitted offer is a bit on the yellow side when it comes to colour”*

### **Din ir-raguni hija ghal kollox irregolari u tmur kontra t-test tad-dokument tas-sejha nnifsu.**

Fis-sezzjoni “Specifications”, pagna 5 tad-dokument, senjatament Specification No. 2 jinghad hekk:

*“The pre-mixed mortar to be used for plastic repair shall have a COLOUR VISUALLY COMPATIBLE WITH LOCAL STONE (i.e. BEIGE TO YELLOW OCHRE i.e. RAL 1001 to RAL 1024”.*

Il-firxa ta' RAL 1001 sa<sup>1</sup> RAL 1024 tindika firxa ta' sfumaturi ta' kulur partikolari li jikkostitwixxu standards internazzjonali. L-esponenti qeghda tannetti ma' din l-oggezzjoni *chart* li turi l-firxa kollha minn RAL1001 sa RAL1024. M'hemmx dubju, li diversi minnhom ghandhom sfumatura skura ta' isfar, izda li l-Awtorita' Kontraenti accettathom bhala prodott konformi mar-rekwiziti tas-sejha.

Anke testwalment, l-Awtorita' Kontraenti ssemmi li l-firxa ghandha tkun ta' "Beige" sa "Yellow Ochre". Jekk wiehed ifittex il-kulur Yellow Ochre f'tiftixa semplici *online*, m'hemmx dubju wkoll li dan il-kulur huwa ta' sfumatura safra pjuttost skura.

Minkejja dan, il-prodott offert mill-esponenti, li certament jaqa' fil-firxa mitluba mill-Awtorita', lanqas huwa ta' xi sfumatura ta' isfar skur – del resto – accettat fid-dokument tas-sejha – u huwa prodott li l-esponenti ilha tuza ma' diversi entitajiet pubblici, inkluz mal-Awtorita' Kontraenti, f'diversi progetti ohra, ghall-istess skop ta' tiswija jew rimpjazzar ta' gebra lokali.

L-esponenti qed tannetti, ghal dan il-ghan, ritratt ta' xoghol ezegwit minnha stess f'progett iehor fejn intuza proprju l-istess prodott ghall-istess skop u li turi x-xebh kwazi preciz, tal-kulur tal-prodott tal-esponenti mal-gebra lokali.

Ghal dawn ir-ragunijiet kollha, din l-ewwel raguni moghtija mill-Awtorita' Kontraenti ma tiswiex u ghandha tigi mwarrba.

(ii) "it is very hard to finish due to large grains"

Ibda biex, l-Awtorita' Kontraenti ma tghid xejn dwar il-qies tal-*grain* tal-prodott. Fis-sezzjoni *specifications* jissemmew hwejjeg ohra, fosthom li jrid ikun konformi ma' Standard partikolari EN459-1:2010 (liema standard – tajjeb jew hazin, gie irtirat).

Il-prodott tal-esponenti huwa ghal kollox konformi mal-istandard tal-2010, kif ukoll mal-istandard tal-2015 (li rimpjazzah) u standards sussegwenti – li fil-verita', jezigu li l-*grain* ma tkunx inqas minn certu qies u mhux li ma tkunx akbar.

F'kull kaz, l-ispecification partikolari ma kinitx tiffirma parti mid-dokument tas-sejha u ghalhekk, illum, l-Awtorita' Kontraenti ma tistax ittiha bhala raguni la darba ma talbithiex espressament fid-dokument innifsu.

Ghal dawn ir-ragunijiet, din ir-raguni ghandha wkoll titqies bhala wahda invalida.

### **Dwar ir-Raguni ghall-Kancellament**

Sussegwentement, u fl-istess ittra, l-Awtorita' Kontraenti tghid li hija qed taghzel li tikkancella t-tender in kwistjoni ai termini tal-artikolu 18.3(a) tal-General Rules Governing Tenders.

Hawnhekk l-Awtorita' Kontraenti tghid hekk:

Gjaladarba r-ragunijiet li bihom l-Awtorita' Kontraenti qieset li l-esponenti hija *technically non-compliant* ma jissussistux, ma kien hemm ebda raguni ghall-kancellament tas-sejha a bazi tal-artikolu 18.3(a) tal-General Rules Governing Tenders.

M'hemmx dubju li l-prezz offert mill-esponenti kien "financially worthwhile" ghaliex huwa biss madwar €400 aktar mill-*estimated procurement value*.

Konsegwentement, anke l-ghazla ghall-kancellament tas-sejha ghandha tigi revokata.

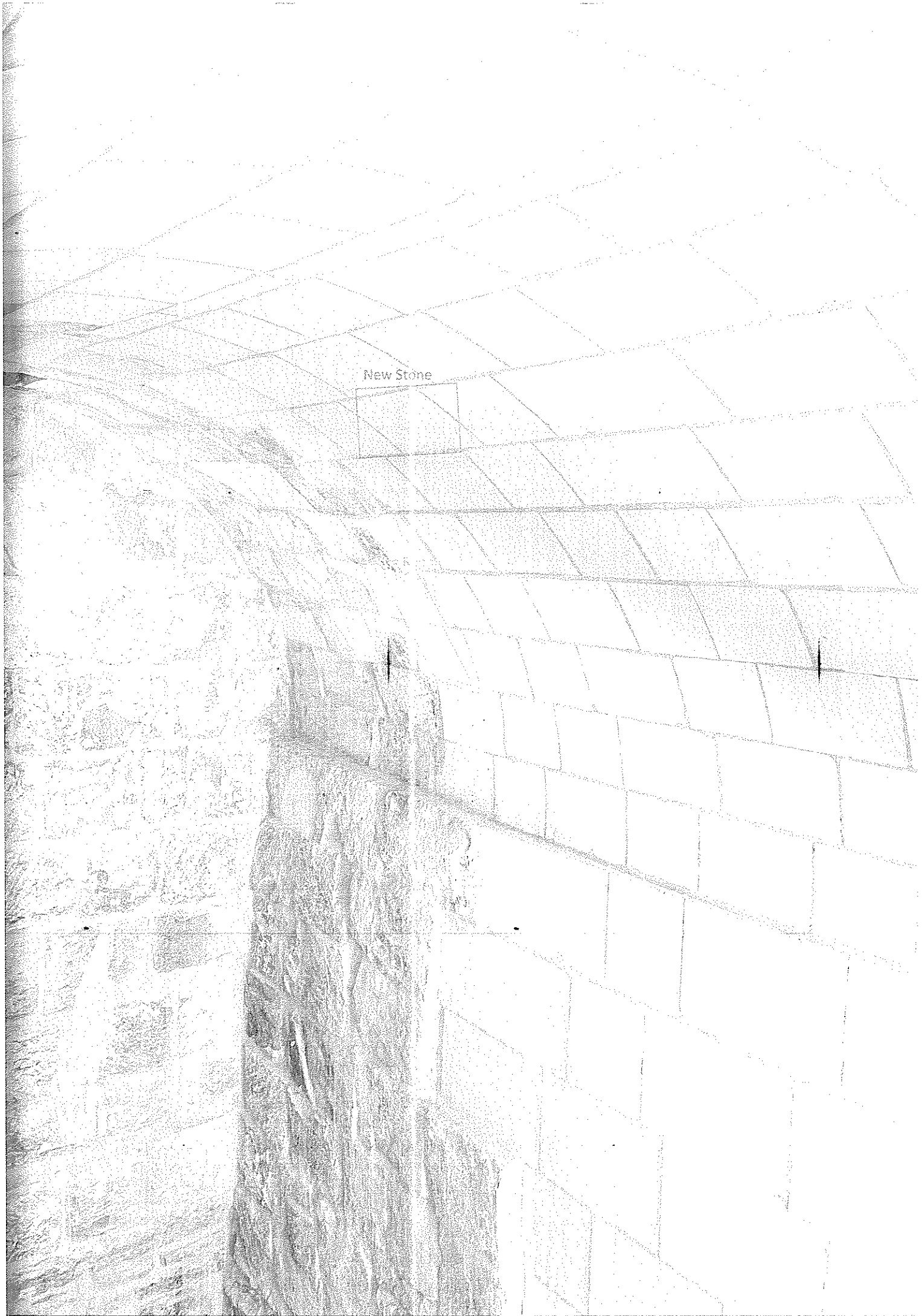
