

Data Protection Notice

Purpose: The personal data collected by the Malta Police Force (MPF) will be processed to handle your case. It may be further processed for the prevention, investigation, detection, and prosecution of criminal offences, or for activities involving the maintenance of public security, or other purposes as may be authorised or required by law.

Contact Details: If you provide the Police with any contact details, such as a mobile number or additional addresses, this information will be included in the Police databases and may be used by the Police to contact you regarding any relevant matter. Therefore, it is important to ensure that you promptly update the Police with any changes to your contact information, to ensure that you can be reached directly when necessary and to prevent any related matters from being disclosed to third parties.

Legal Framework: The authority of the Police to execute criminal law enforcement functions primarily derives from the Criminal Code (Chapter 9 of the Laws of Malta) and the Police Act (Chapter 164 of the Laws of Malta), along with other laws governing specific activities depending on the nature of the report, including whether it relates to criminal law enforcement matters or not. For instance, the reporting and handling of lost items is based on the Civil Code (Chapter 16 of the Laws of Malta). The processing of personal data in the criminal law enforcement context must adhere to S.L.586.08. On the other hand, for reports that do not involve any criminal matter, the processing of must adhere to the General Data Protection Regulation (GDPR) (Regulation (EU) 2016/679. Additionally, specific legislative instruments of the EU may regulate certain instances of processing, particularly if information is exchanged with other Member States within the framework of Police cooperation in the criminal context, including via the Schengen Information System.

Exchanges: If necessary, for the prevention, investigation, detection, and prosecution of criminal offenses, or for activities involving the maintenance of public security, your data may be shared with police or judicial authorities in other member states or third countries, pursuant to a bilateral or multilateral agreement to which Malta is a party, or in accordance with European Union or national laws in the field of police and judicial cooperation. Personal data may be exchanged with other legally constituted authorities, bodies, or entities, government departments, or third parties only when authorized by law.

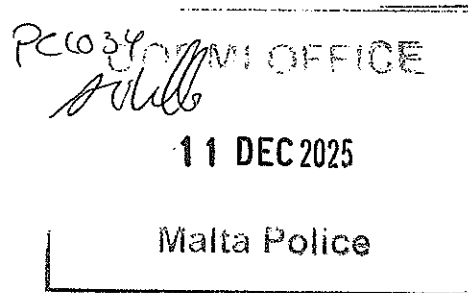
Traffic-Related Incident: Reports concerning road traffic incidents involving motor vehicles, information contained in reports—including identification details of involved parties, their versions and statements of events, and other relevant information that may aid in determining claims and preventing insurance fraud—may be shared with insurers.

Non-Criminal Reports: Personal data processed in connection with non-criminal reports is typically not shared with any third party, except in cases where the report involves other individuals. In such instances, both the identity of the person filing the report and its contents will be disclosed to the concerned individual(s). In specific instances, particularly when reports pertain to lost objects like identity documents and passports, an alert will be issued on the Schengen Information System.

Retention: Data processed is subject to varying time periods, with the MPF adhering to the durations outlined in the Data Retention Schedule for storing such personal data.

Security Measures: The MPF is responsible for implementing robust security measures to safeguard the data of individuals. This involves establishing audit trails and implementing internal policies. Access control measures are enforced to manage the authorization of staff processing the data. Members of the MPF are bound by the duty of confidentiality.

Your Rights: You have the right to request access to your personal data being processed by the MPF and to have it rectified or deleted if it is incorrect or processed unlawfully. You also have the right to object to or request the restriction of the processing of your personal data. However, please note that these rights may be restricted according to the law, including to ensure that no criminal investigations are prejudiced and to safeguard the rights and freedoms of others. These rights can be exercised by making a written request to the Data Protection Officer within the MPF. Address: The Data Protection Officer, Data Protection Office, Malta Police Force General Headquarters, Floriana, Malta (dpu.police@gov.mt) You further have the right to lodge a complaint with the Office of the Information and Data Protection Commissioner (IDPC), or request verification of the lawfulness of processing. 


